- 1) **Q:** Section 01 45 00 Quality Control The documents specify that the dedicated field QC Manager may also serve as the SSHO. Can this person also serve as the Project Superintendent or maintain any other duties?
 - **A:** Per Specification Section 01 45 00; 1.04; H the Quality Control Manager may also serve as site safety officer. This person may not serve as the Project Superintendent or maintain any other duties, unless those duties are providing qualified, independent inspection services. If the QC Manager is to also provide inspection services, then he must have an independent relationship with the Contractor.
- 2) **Q:** Section 09 97 13 Coatings Can the independent NACE Certified Coating Inspector perform other onsite duties?
 - **A:** Per Specification Section 09 97 13.23; 1.05; B Inspection shall include an independent NACE Certified Coating Inspector. This person may not perform any other onsite duties, with exception of performance of other qualified independent quality control or safety services, such as QC Manager / site safety officer, as long as these services all remain independent of the Contractor.

Note: Any reference to NACE Certified Inspector in the Contract Documents implies that the inspector is a Level 3 NACE Certified Coating Inspector, or that this inspection is performed by a NACE Level 1 or Level 2 Coating Inspector under the direct supervision of a NACE Level 3 Inspector in accordance the NACE Coating Inspector Program. If a NACE Level 1 or Level 2 Coating Inspector working under the direct supervision of a NACE Level 3 Certified Coating Inspector is used to satisfy the coating inspection requirement for this project, the Level 3 inspector must work for the same Company as the Level 1 or Level 2 inspector.
