NOTICE TO BIDDERS:

Bidders must acknowledge receipt of this addendum prior to the hour and date set for the bid due date by one of the following methods:

- (a) By acknowledging receipt of this addendum on the proposal form submitted.
- (b) By email or telefacsimile which includes a reference to the project and addendum number.

The bid documents require acknowledgment individually of all addenda to the drawings and/or specifications. This is a mandatory requirement and any bid received without acknowledgment of receipt of addenda may be classified as not being a responsive bid. If, by virtue of this addendum it is desired to modify a bid already submitted, such modification may be made by email or telefacsimile provided such an email or telefacsimile makes reference to this addendum and is received prior to the opening hour and date specified above.

The Bid documents for the above project are amended as follows (All other terms and conditions remain unchanged):

CONTRACT PROVISIONS AND SPECIFICATIONS

Item #1 Section 1.08 Bid Forms G, should now read, “ **that the bid will remain open and valid for at least 10 days**”.

Item #2 Section 2.01 Contract Term, should now read, “The length of the contract will be from the date of award, approximately March 25, 2021, for approximately Final delivery date as indicated on the Bid Schedule.”

Item #3 Remove and replace Bid Schedule in its entirety.

QUESTIONS AND ANSWERS

Question: The ITB mentions steel plate. Is there any steel plate in the procurement?

Answer: *The procurement is limited to the items listed on the bid schedule only. This procurement does not include steel plate.*

Question: Reference Attachment A, Section 1.3 Submittals, B. Shop Drawings: Show fabrication details for all products listed in the bid schedule.

Please confirm no shop drawings are required to be submitted for the procurement of the pile materials.

Answer: *Shop drawings are not required.*

Question: Please confirm no coatings are required for the Steel H-Piles.

Answer: *No coating system is required.*

Question: Please confirm no coatings are required for the Steel Pipe.

Answer: *No coating system is required.*

Question: Would you confirm if there is any Domestic requirement for steel?

Answer: *There is no requirement for Buy American Steel for this ITB.*

Question: Will the contractor be able to deliver the steel directly to the Port of Seattle as soon as the steel becomes available? I.E. Contractor executes contract 3/25/2021.
Deliver all steel to Port of Seattle by 4/25/2021.

Answer: *Contractor may assume that owner will take delivery of the products no more than 10 days prior to final delivery date. Contractor is responsible for all storage coordination and costs associated with early delivery of the products.*

Question: Who is responsible for offloading the truck once the steel is delivered to the Port of Seattle?

Answer: *Contractor is responsible for coordinating all loading and offloading operations.*

Question: Will the contractor be able to get paid 30 days from when the steel is delivered to Seattle, WA Loaded Truck?

Answer: *The AEA will pay all invoices within thirty (30) days of invoice approval by the Project Manager.*
